- Tax Reference Number

Once Unemployed or Unemployed Disabled learners have submitted the required documentation to Skill Tech Solutions, they will be invited to a Learnership interview and assessment to establish if they are suitable and qualified for the relevant Learnership Programs available. Once learners are approved, they will enter into a contractual agreement with our relevant client and will commence with their 10 to 12 month Learnership program.
